8. To exempt and relieve the Professional Fishing Guide and the A.I.G.U.P.P. (Italian Trust of Professional Fishing Guides) from liability for personal injury, property damage or wrongful death not depending directly from the fishing guide professional work and to take direct responsibility for any accident or damage caused by the minor child to any third party during the activity;
